

## An annotated checklist of the genus *Gymnocalycium* Pfeiffer ex Mittler (Cactaceae)

An annotated nomenclatural checklist of the genus *Gymnocalycium* (Cactaceae) is compiled; additional comments about problems of typification and citation in the family are given. Lectotypes for the following names of taxa now combined in *Gymnocalycium* are designated here: *Echinocactus andreae* Boedeker, *Frailea bruchii* Spegazzini, *Gymnocalycium lafaldense* Vaupel. A new combination, *Gymnocalycium mackieanum* (Hooker) Metzing, Meregalli & Kiesling, is given.

Key words: Cactaceae, *Gymnocalycium*, nomenclature, typification.

*It is appropriate to begin a study of the Cactaceae with the statement that the classification of this family is in a state of absolute chaos.*

(L. Croizat, 1943)

Up to the present time the taxonomy of the Cactaceae has been largely based on Britton & Rose (1919-1923) and Backeberg (1958-1962); modern, comprehensive monographs are lacking. Only in this century literally thousands of new names were added, without any critical revision of their nomenclatural validity, let alone their systematic status. Only about 10 of the nearly 100 genera currently accepted have been subject to modern systematic revisions, sometimes limited to single geographical areas. Recently the controversial topic of generic classification was examined by a "working group" of the IOS (International Organization for Succulent Plant Study), leading to publication of some preliminary reports (Hunt & Taylor, 1986, 1990) and of the CITES Cactaceae Checklist (Hunt, 1992), where the specific names in current usage are listed. The latter was compiled for the purpose of CITES and is not a nomenclatural checklist; the species-list for the majority of the genera was based simply on preliminary evaluations, nomenclatural checklists or taxonomic monographs being available only for a few of them.

*Gymnocalycium* is a genus belonging to the tribe Trichocereeae F. Buxbaum, with about 40-50 species distributed in Southern Brazil, Paraguay, Bolivia, Uruguay and Argentina. Its status as a distinct genus has been accepted in the most recent classification of the family (Barthlott & Hunt, 1993). Because of interest among collectors, the taxonomy of the genus has been marred by a tremendous proliferation of names at or below specific rank (up to about 500!). To increase the nomenclatural ballast, a similarly excessive production of infrageneric names was proposed by various authors, usually without any critical eva-

luation of the phyletical relations among the groupings. Moreover, many of the names were invalidly described.

No systematic monograph has recently been published; a few name-lists of the genus exist, but these are not scientific contributions, rather works realized by, and addressed to, amateurs and collectors; they do not contain any evaluation of the nomenclatural validity of the names (Putnam, 1969; Crombez, 1985; Brockmann, 1986). Although these lists include many data, some names are missing and neither the reported citations nor the original descriptions were checked. A survey of the genus (Meregalli, 1985) included systematic remarks on the taxa, but nomenclatural data were not investigated in detail. Schütz (1986) reproduced the descriptions and added information on many taxa, but he did not make any distinction between validly and invalidly published names, and the latter were kept in use. A partial list, including the names of the Cactaceae published between 1950 and 1990 and based on the *Repertorium Plantarum Succulentarum*, exists (Eggli & Taylor, 1992), but even this is not complete. The most recent checklist (Pilbeam, 1995) is not a systematic monograph but rather, as the title suggests, "A Collector's Guide". A list providing the bibliographical data for Fric's (mostly invalid) names was compiled by Zazvorka & Sedivy (1991).

The present work is the first attempt to compile a complete nomenclatural checklist for the genus *Gymnocalycium*, as a contribution to the IOS Cactaceae Working Group.

## Types

A major problem in the systematics of the Cactaceae is the deficiency of deposited type material, which can hardly be justified by a certain difficulty in preparing herbarium specimens (Leuenberger, 1987; Hunt, 1991; Zappi, 1994). The main reason is that most descriptions (especially those published in this century) were provided by amateurs who had little or no knowledge of the nomenclatural rules (see comments by Croizat, 1943; Eggli, 1985a; Hunt, 1991). Even when Art. 36.1 and 37.1 (ICBN, Greuter (ed.), 1994) were fulfilled (and this is not always the case), there are examples where the application of Art. 8.2 was infringed by referring to the deposition of the holotype in Botanic Garden collections, but very often this was a living plant. A similar (but in this case deliberate) misapplication of the same article 8.2 occurs when the deposition of the holotype in an institute is cited in the protologue, but the living specimen never left the author's greenhouse. Although some cases have been documented by us (and will be indicated in notes under the relative taxa), it is clear that it is often impossible to ascertain whether really no type material was deposited or if it was eventually lost, and in consequence these names can hardly be invalidated. We have indicated the doubtful cases with an asterisk (\*) beside the name of the taxon. In other instances material labelled as type is present in some institutes, although no such indication is reported in the original descriptions: this is the case of various samples labelled "Isotype" which are preserved in ZSS (Eggli, 1987). It may be difficult to ascertain whether these specimens should be interpreted as true isotypes or only as specimens without type status, which bear the same "field number" as the types but do not belong to the original collection (for some remarks on the "field-numbers" see Leuenberger, 1984).

## About the combinations attributed to Berger (1929)

When Berger (1929) published his book "Kakteen" he used a broad "conservative" concept of genus (Gibson *et al.*, 1986; Leuenberger, 1986; Barthlott, 1988). In a former paper dealing with the phylogeny of the Cactaceae (Berger, 1926) he had followed the more splitting classification of Britton & Rose (1919-23), listing the so-called "Kleingattungen" [small genera] and showing their systematic connections; however, their taxonomic rank was not evaluated (Berger, 1926: 25-26). In "Kakteen" he gave a "Übersicht über das

System der Kakteen, wie es hier angewendet werden mußte" [survey over the system of the cacti as it had to be used here] (Berger 1929: V-VIII). He accepted 41 genera, which were segregated in further "Sektion", "Sippe" and "Untergattung" (these ranks, in this order, are not in accordance with Art. 4.2 of the present code). From this system it is however clearly understandable which taxa were accepted as genera and which were placed in infrageneric ranks. *Gymnocalycium* is usually listed as a subgenus ("Untergattung") of *Echinocactus*, but once it is mentioned as a "Sektion" (Berger 1929: 26). Although Berger seemed aware that *Echinocactus* is not a natural (monophyletic) group, he retained it "nur aus praktischen Gründen [only for practical reasons]" (Berger 1929: 17; see also Barthlott, 1988). In the chapter with the descriptions he listed the specific epithets in combination with the genus he accepted, adding the infrageneric taxon with author citation, e.g.:

***Echinocactus sutterianus*** Schick (1927).- *Gymnocalycium Berger*. [sic!, in Berger, 1929: 220].

In similar form (behind the subgenus) he also listed synonyms, e.g. :

***Echinocactus crassihamatus*** Web (1896) - *Ferocactus Br. u. R.* - *Echinocactus Mathssonii* Berge (1897) [sic!, in Berger, 1929: 241].

In the index the epithets are listed both below the genus he accepted and below the name of the infrageneric taxon (for example, the epithet *sutterianus* is reported twice, once below *Echinocactus* and once below *Gymnocalycium*), sometimes with an asterisk and the explanation: "Die mit \* versehenen Namen werden hier zum ersten Mal genannt [the names marked with \* are mentioned here for the first time]". This led to questions whether such names could be accepted as valid combinations (Croizat, 1947; Leuenberger, 1986; Metzing, 1988b; Taylor, 1992; Leuenberger, 1993). In the case of *Gymnocalycium*, two points must be analyzed:

- whether the names listed in the index under *Gymnocalycium* and marked with an asterisk (Berger, 1929: 341) are validly published names and, in this case,
- whether these names are validly published combinations in the genus *Gymnocalycium*.

In the first instance these names could be considered as validly published: the indication to the page refers to a basionym and to the original publication. Berger's concept of the taxon *Gymnocalycium* must be analyzed: both in the systematic list and in the description of the species (Berger, 1929: VII, 219) he clearly stated that he regarded *Gymnocalycium* as a subgenus of *Echinocactus* (see also Mottram, 1990: 45); according to Berger, the species should be indicated as, for example, *Echinocactus* (subg. *Gymnocalycium*) *sutterianus*. However, many authors adopted Berger's names as combinations in the genus *Gymnocalycium* (see comments in Leuenberger, 1986; Metzing, 1988). In our opinion, this interpretation does not reflect Berger's opinion, and anyway it would not lead to validly published *Gymnocalycium* names according to Art. 34.1. In fact, Berger himself did not accept *Gymnocalycium* at genus rank in the systematic treatment (Art. 34.1a) and he also suggested that taxonomy would be further developed (Art. 34.1b). Finally, as in the systematic part the specific synonyms are listed together with the infrageneric names (see *E. crassihamatus* example), Art. 34.1c must also be considered. Therefore we do not accept Berger as author of the following combinations: *Gymnocalycium bodenbenderianum*, *Gymnocalycium hossei*, *Gymnocalycium quehlianum*, *Gymnocalycium sigelianum* and *Gymnocalycium sutterianum*.

#### SCOPE OF THE LIST

All the published names of taxa belonging to the genus *Gymnocalycium* are listed. Each epithet in or below the rank of species is listed in its *Gymnocalycium* combination; combinations of the same epithet in other genera are listed immediately below. In the

“cactus literature”, particularly in trade lists, many other names have appeared without description; we have generally ignored them, reporting here only those which had wider use (and sometimes were even cited as validly published). In an appendix the known *nomina nuda*, without further specification of origin (place of publication), are cited. Names of cultivars or hybrids are not reported.

The original description of every name was checked and its validity according to the ICBN (1994) assessed (the following publication was not available: Cels, 1847: Portefeuille des Hort.) Validly published names are printed in ***bold italics***; invalid and illegitimate names are printed in *italics*; full references to the place of publication are added (periodical titles are abbreviated according to Bridson, 1991 and Eggli, 1985b). Indication of known type material includes references to collector, type locality (with collecting data according to the protologue) and acronyms of the herbaria where types are deposited (according to the original description or to lists of type material preserved in institutes; acronyms are according to Holmgren *et al.*, 1990). Where no indication of types is given it means that it was lacking in the original publication. Type material personally examined by one of us (RK, DM) is marked with “!”, although it was not the aim of this project to check all the deposited type material. For invalid, illegitimate or incorrect names the articles of the ICBN which have been contravened are indicated in brackets. Notes referring to any particular interpretation are added when necessary; however, taxonomic evaluations are usually avoided, as these are beyond the scope of the present work.

In a few cases an illustration is here used as lectotype, according to Art. 9.2 and 9.9: a lectotype has been selected only when:

- no herbarium type material was apparently preserved or is known to exist today;
  - the protologue reported a precise type locality and the description is clearly referable to the population known to be growing there;
  - the illustration used as lectotype matches the description and was included in the original publication;
- the typification of the name is needed in order to preserve the stability of nomenclature.

Every case is detailed in the note accompanying the designation.

No type is designated when any indication in the protologue is at variance with the present systematic knowledge, when no type locality was given or when the illustration cannot be clearly referred to the specimens used for the description. Similarly no type is designated in cases where a systematic revision is needed to fix the application of a name, when typification should preferably be associated with the designation of an epitype or when a neotype is needed.

Names of infraspecific taxa are trinomials. In some cases infraspecific taxa were published as a combination of more than one infraspecific rank, indicating the full infraspecific classification (e.g. *Gymnocalycium catamarcense* subsp. *catamarcense* f. *belense* = *Gymnocalycium catamarcense* f. *belense*, see Art 24.1, Ex.1). These names are listed here as they were published, although the classification is nomenclaturally irrelevant.

Unless otherwise specifically indicated, we would like to point out that we do not accept any name that might be inadvertently validated in this paper.

## CHECKLIST

### Names in the rank of Genus

#### *Gymnocalycium* Pfeiffer ex Mittler

Taschenbuch für Cactusliebhaber 2: 124, 1844. Type: *Cactus gibbosus* Haworth, 1812.

Note: The genus *Gymnocalycium* was introduced by Pfeiffer, but was first validly published by Mittler (1844, see Metzing, 1988a; Eggli & Metzing, 1992). As the spelling

used by Mittler (1844, "*Gymnocalicium*") was different from that used by Pfeiffer in his works (Pfeiffer, 1845-1846, "*Gymnocalycium*") and the last spelling has been used in all subsequent reference works about Cactaceae, it was proposed to conserve the currently used spelling "*Gymnocalycium*" (Eggli & Metzing 1992). The Nomenclature Committee stated that the correction of Mittler's spelling is possible without conservation and that the name should be cited as *Gymnocalycium* Pfeiffer ex Mittler 1844 (Brummitt 1994).

The type of the genus was designated by Pfeiffer (1874, see Eggli & Metzing, 1992: 142). Heath (1992) subsequently stated that *E. denudatus* had been previously designated as type of *Gymnocalycium* by Salm-Dyck (1850), but the note "Hujusce generis typus in flore *E. denudati* inquirendus est ..." given by Salm-Dyck (l.c.: 171) can be interpreted only as meaning that the morphological characters of the flower of *Echinocactus denudatus* are representative for the genus. This statement cannot be accepted as an earlier lectotypification in the sense of the ICBN.

***Brachycalycium*** Backeberg, in: Cactaceae (DKG) s. vol. (1941, pt.2): 76, 1942. Type: *Brachycalycium tilcarense* Backeberg.

Note. This monotypic genus was described by Backeberg on the basis of irrelevant differences in flower morphology for a taxon now referred to as an infraspecific form of *Gymnocalycium saglionis*. It is therefore considered a synonym of *Gymnocalycium* (Hunt & Taylor, 1986; Barthlott & Hunt, 1993).

### Names in infrageneric ranks

The infrageneric classification is mainly based on seed characters. Fric (in Kreuzinger, 1935) first paid attention to this and published a system, which anyway brought no validly published names. This system was later worked out by Schütz (1962, 1969). Buxbaum (1968) published a slightly different system, this too mainly based on seed characters, using different taxonomic ranks. Meanwhile Backeberg had published in various papers (e.g. 1942, 1959) generic segregations based on the morphology of plant and flower. Completely different systems, based on the stem morphology, were invalidly named by Ito (1950, 1957).

Note: Ito (1957) erroneously attributed this name to Ito (1950).

***Gymnocalycium* subgen. *Pirismineum*** H. Till & M. Hesse, Pl. Syst. Evol. 149: 149-153, 1985. Type: *G. zegarrae* Cardenas.

Note: Type of an infrageneric taxon is the type of a species name (Art. 10.1). Till & Hesse (l.c.: 151) list seeds ex coll. H. Till no. 1322, leg. M. Cardenas s.n. under “species typica”. These seeds can hardly be recognized as type of the species name (see type of *G. zegarrae*).




Fig. 1 - *Gymnocalycium lafaldense* Vaupel. Lectotype. Original illustration from Vaupel, Z. Sukkulantenk. 2(14): 192, 1924.




Fig. 2 - *Gymnocalycium mackieanum* (Hooker) Metzing, Meregalli & Kiesling. Original illustration from Curtis's Botanical Magazine, pl. 3561.

Note. *G. bruchii* is a species widely distributed and fragmented in various populations of uncertain systematic status. The illustration in Spegazzini (l.c.) matches the description and clearly refers to the original collection; the typification of Spegazzini's epithet guarantees the correct application of the name and defines the typical population (see also discussion for *G. lafaldense*) (for missing herbarium material see Kiesling, 1984: 234-235). The original attribution of this taxon to *Frailea* has been extensively discussed (Hosseus, 1929; Oehme, 1941; Simon, 1963; Frank, 1975).

In the same publication there is an illustration titled *G. mihanovichii* var. *stenosstriatum* var. nov.; it is not known whether this picture refers to *G. mihanovichii* var. *angustotriatum* and is an alternative name (which would invalidate the name *angustostriatum* according to Art. 32.4), if the caption is a typographical mistake, or if the picture depicts a different variety of the species, not described.

Although the description indicates Paraguay as country of origin, the illustration (later reproduced with the addition of three flowers, Lemaire, 1847: pl. 15) clearly matches the actual interpretation of *G. monvillei* for a species distributed in the Argentine province of Cordoba (Till & Neuhuber, 1993). The typification of Lemaire's epithet, supported by an epitype of known provenance, would be desirable to guarantee the stability of the infraspecific nomenclature of the species.

This interpretation, although nomenclaturally correct, seems systematically doubtful: Backeberg's descriptions (1936, 1959) may in fact represent a form of *G. mostii* (see Meregalli, 1985).

Note. Hooker (l.c.) clearly stated that he had only one plant, which was illustrated in the plate ("... sent one specimen [the one here figured] ..."). This should be considered the holotype according to Art. 9.1 (& note 1). The name was used for plants from the Argentine province of Cordoba, and is now considered a synonym of *G. monvillei* (see Lambert, 1993a). It has recently been suggested (Till & Till, 1994) that *E. multiflorus* may refer to a Paraguayan species, but no plant matching Hooker's illustration is known from that area; this opinion is based on cultivated material of undetermined origin, which, anyway, does not particularly match the original illustration. This is a quite common case in cactus taxonomy, where many old descriptions were vague and incomplete, did not report the geographical origin of the taxon (or these data were wrong), seldom had illustrations and no type material was preserved. In all these cases the principle of stability in nomenclature should be carefully considered before any change in the current interpretation of a name is proposed (for remarks regarding the

concepts of the ICBN in respect to the problem of stability in nomenclature see Smith & Hawksworth, 1994).

Note. The indication "Holotype in the Municipal succulent collection of Brno", given in the protologue, probably refers to a living specimen (nom. inval. Art. 8.2?).

## An annotated checklist of the genus *Gymnocalycium* Pfeiffer ex Mittler – Addenda et Corrigenda

Three years ago a list of *Gymnocalycium* names was published by Metzing et al. (1995). Meanwhile some new names were published and it became obvious that some additions and corrections to the nomenclatural checklist are necessary. Therefore we submit here a supplement in which new names published up to the end of November 1998 are considered. The new entries, published after 1995 or missed in the list are marked with a ¶ here, and corrections or additions are underlined. For further explanation, including the use of the asterisk (\*), see Metzing et al. (l.c.).

### Names in and below the rank of species

*Gymnocalycium asterium* var. *minimum* Pazout, Friciana 1(6): 7 (1962), nom. inval. (Art. 43.1). Based on *G. stellatum* var. *minimum* Pazout (1960) nom. nud.

¶*G. berchtii* Neuhuber, Gymnocalycium 10(3): 218–220 (1997). Type: Argentina, Prov. San Luis, Los Chañares, 690 m, 16 Dec 1989, G. Neuhuber 89-158 (WU, holo.).

*G. friedrichii* (Werdermann) Pazout, Friciana 4(23): 12 (1964), nom. inval. (Art. 34.1). Based on *G. mihanovichii* var. *friedrichii* Werdermann (1936).

*G. friedrichii* var. *angustostriatum* (Pazout) Pazout, Friciana 4(23): 12 (1964) nom. inval. (Art. 33.2, 43.1).

*G. friedrichii* var. *moserianum* Pazout, Succulenta 45: 99–100 (July 1966), nom. inval. (Art. 43.1, 37.1). Also published in Friciana 6(37): 19–20, Ills. 1–4. (August 1966).

¶*G. gibbosum* f. *cerebriforme* (Spegazzini) Papsch, Gymnocalycium 9(4): 201 (1996). Basionym: *Echinocactus gibbosus* var. *cerebriformis* (1899). Note: This name of Spegazzini is based only on a cristate. The combination as a forma of *G. gibbosum* is formally correct, although quite superfluous from a taxonomic view. Papsch (l.c.) designates an epitype [Argentina, Prov. Buenos Aires, near Carmen de Patagones, embankment of Rio Negro, 7 Oct 1989, W. Papsch 89-54/67a (WU)], although the supposed type (LPS 23055) was not studied by him. The concept of the epitype is to

achieve certainty in the application of a name, when the original material is demonstrably ambiguous. This may be contravened, when the original material will not be studied carefully to check that epitype and original material are really not heterogeneous.

¶**G. gibbosum** ssp. **ferox** (Labouret ex Rümpler) Papsch, *Gymnocalycium* 9(4): 201 (1996). Basionym: *Echinocactus gibbosus* var. *ferox* Rümpler (1885). Note. Papsch (l.c.) designates an epitype [Argentina, Prov. Chubut, Ruta 1, Cantera Namuncura, 6 Feb 1992, W. Papsch 92-136/196 (WU)], although original material is not known and neither a lecto- nor a neotype has been designated already; this contravenes ICBN Art. 9.7.

¶**G. gibbosum** var. **brachypetalum** (Spegazzini) Papsch, *Gymnocalycium* 9(4): 201 (1996). Basionym: *Echinocactus gibbosus* var. *brachypetalum* Spegazzini (1902). Note: Papsch (l.c.) designates an epitype [Argentina, Prov. Rio Negro, Ruta 2, 30 km N of San Antonio de Oeste, Barrancas de Gualichos, 1 Oct 1989, W. Papsch 89-37/47 (WU)], although a supposed type (LPS 23048), cf. Kiesling (1984), was not studied by him.

¶**G. gibbosum** var. **chubutense** (Spegazzini) Papsch, *Gymnocalycium* 9(4): 201 (1996). Basionym: *Echinocactus gibbosus* var. *chubutensis* Spegazzini (1925). Note: Papsch (l.c.) designates an epitype [Argentina, Prov. Chubut, S of Camarones, 7 Feb 1992, W. Papsch 92-139/205 (WU)], although no original material is known and neither a lecto- nor a neotype has been designated previously; this contravenes ICBN Art. 9.7.

*G. gibbosum* var. *leucodictyon* (K. Schumann) Y. Ito nom. inval. (Art. 33.2) Explanatory Diagram of Austroechinocactinae: 190 (1957). Basionym: *Echinocactus* var. K. Sch., 1898 [sic!]. *Echinocactus gibbosus* var. *leucodictyon* Salm-Dyck, Cact. Hort. Dyck. 1849: 34, 171 (1850).

¶**G. gibbosum** var. **platense** (Spegazzini) Castellanos & Lelong, Cact. Succ. J. (US) 12: 51 (1940). Basionym: *Echinocactus platensis* Spegazzini (1896).

¶**G. horridispinum** var. **achirasense** (H. Till & Schatzl) Lodé, Cact. Aventures (27): 29 (1995). Basionym: *G. achirasense* H. Till & Schatzl (1987).

**G. lafaldense** f. **deviatum** Oehme, Cactaceae (DKG) 1941(1): 29, 30/2 (1941). Note: In this volume the leaves were numbered, not the pages, so that every leaf number corresponds to two pages.

**G. lafaldense** f. **enorme** Oehme, Cactaceae (DKG), 1941(1): 29, 30/2 (1941).

**G. lafaldense** f. **evolvens** Oehme, Cactaceae (DKG) 1941 (1): 29–30/2 (1941).

**G. lafaldense** f. **fraternum** Oehme, Cactaceae (DKG), 1941(1): 30/1–2 (1941).

**G. mazanense** var. **rhodantherum** (Boedeker) Backeberg in Backeberg & Knuth: Kaktus-ABC: 291 (1936), nom. illeg. (Art 52.1). Basionym: *Echinocactus rhodantherus* Boedeker, Kakteenkunde [1934]: 13–14 (1934).

¶**G. mazanense** var. **roseiflorum** (Backeberg) H. Till in H. Till & W. Till, *Gymnos* 4(8): 79 (1987), nom. inval. (Art. 33.1). Basionym: *Echinocactus mazanensis* var. *rosiflorus* Backeberg (1932).

*Echinocactus mazanensis* var. *rosiflorus* Backeberg, Kakteenfreund 1(12): 134 (1932). Note: In Metzing et al. (1995: 210) we erroneously cited Backeberg (1932) as the author of the combination in *Gymnocalycium*. The spelling "rosiflorus" may be an error for "roseiflorus" as the flower is of pink colour and not similar to the flower of a rose. However, Backeberg (1936: 291; 1959: 1767) retained this spelling.

**G. mihanovichii** var. **angustostriatum** (\*) Pazout, Friciana 1(7): 3–4 (1962). Note: The indication "Holotype in botanic garden of the Carolinensis University of Prague"

given in the protologue probably refers to a living specimen (nom. inval., Art. 8.2?). Original spelling: "angusto-striatum". In the same publication there is an illustration titled *G. mihanovichii* var. *stenostriatum* var. nov.; this was a typographical mistake and corrected in Fricana 1(12): i. (1962).

**G. mihanovichii** var. *rysanekii* (\*) Pazout, Fricana 5(29): 11 + ills (1965). A different spelling – *G. mihanovichii* var. *rysanekianum* – was used by Pazout in Fricana 5(35): 19 (1965).

**G. mostii** (Gürke) Britton & Rose, Addisonia 3: 5–6, pl. 83, (1918). Basionym: *Echinocactus mostii* Gürke (1906).

¶**G. nigriareolatum** fa. *carmineum* H. Till, Gymnocalycium 11(3): 255 (1998). Type: Argentina, Prov. Catamarca, W Sierra Ancasti, 8 Oct 1989, H. Amerhauser HA 255-2 (holo BA, iso WU).

¶**G. nigriareolatum** var. *densispinum* Backeberg ex H. Till, Gymnocalycium 11(3): 255 (1998). Type: Argentina, 1963, H. Fechser s.n. ex cult. in coll. H. Till (holo BA, iso WU).

¶**G. nigriareolatum** var. *simoi* H. Till, Gymnocalycium 11(3): 256 (1998). Type: Argentina, Prov. Catamarca, Palo Labrado, 1972, H. Borth BO 126 ex cult. in coll. H. Till (holo BA, iso WU).

**G. paediophilum** F. Ritter ex Schütz, Kaktusy 13(5): 100–101 (1977). Type: Paraguay, Cerro León (PZ), 1963, *F. Ritter* 1179. Note: The original spelling "paediophylum" was a typographical error and was later corrected by Schütz (1986: 104–105).

*G. paediophilum* F. Ritter nom. illeg. (Art. 52.1), Kakteen in Südamerika 1: 269, Ill. 215, (1979) (cf. note in l.c. 2: 707 (1980)). Type: Paraguay, Cerro León, 1963, *F. Ritter* 1179 (U!).

**G. paraguayanense** (K. Schumann) Hosseus, Arch. Esc. Farm. Fad. Cienc. Med. Cordoba 9: 106 (1939). Basionym: *Echinocactus paraguayensis* K. Schumann (1903).

¶**G. pflanzii** ssp. *dorisiae* Amerhauser, Gymnocalycium 11(4): 267–268 (1998). Type: Bolivia, Dept. Tarija, Rio Paichu, H. Amerhauser HA95-1004-2 (holo LPB, iso WU).

**G. platense** (Spegazzini) Britton & Rose, The Cactaceae 3: 163–164 (1922). Basionym: *Echinocactus platensis* Spegazzini (1896).

*Echinocactus platensis* Spegazzini, Contribucion al Estudio de la Flora de la Sierra de Ventana: 28–29 (1896). Neotype (designated by Kiesling, 1982: 441): Argentina, Buenos Aires, Sierra de la Ventana, hills after Estancia las Vertientes, 30 Dec 1981, R. Kiesling 3356.

*Echinocactus gibbosus* var. *platensis* (Spegazzini) Spegazzini, Anales Mus. Nac. Buenos Aires ser. 3, 2: 7–8 (1903). Basionym: *Echinocactus platensis* Spegazzini (1896).

¶**G. platense** var. *hyptiacanthum* (Lemaire) Backeberg in Backeberg & Knuth, Kaktus-ABC: 294 (1936). nom. inval. (Art. 11). Basionym: *Echinocactus hyptiacanthus* Lemaire (1839).

¶**G. platygonum** (H. Till & W. Till) Pilbeam, Gymnocalycium – a collector's guide, 123 (1995), nom. inval. (Art. 33.2). Basionym: *G. riojense* var. *platygonum* H. Till & W. Till (1991).

¶**G. reductum** var. *leucodictyon* (Salm-Dyck) Papsch, Gymnocalycium 10(4): 230 (1997). Basionym: *Echinocactus gibbosus* var. *leucodictyus* Salm-Dyck (1849).

[**G. rhodantherum** (Bödeker) Backeberg in Backeberg & Knuth, Kaktus-ABC: 291 (1936). Basionym: *Echinocactus rhodantherus* Boedeker (1934). Note: This was an erroneous entry by Metzing et al. (1995) and should be deleted from the list. For the correct

entry see *G. mazanense* var. *rhodantherum* (Bödeker) Backeberg (1936).]

- ¶G. *saglionis* ssp. *tilcarense* (Backeberg) H. Till & W. Till, *Gymnocalycium* 10(2): 215 (1997). Basionym: *Brachycalycium tilcarense* Backeberg (1942). Note: Till & Till (l.c.) accept the combination *G. tilcarense* (Backeberg) Schütz, *Monografie der Gattung Gymnocalycium*, 134 (1992). This was not accepted by us (Metzing & al. 1995: 224) and this judgment has to be maintained. Schütz wrote the manuscript for his "Monografie rodu *Gymnocalycium*" in the German language, but the publication was in Czech (Schütz 1986). Neither in this original publication nor in the subsequently published supplement (Schütz 1988) was the combination *Gymnocalycium tilcarense* published. The late Dr Schütz gave the German manuscript to G. Hold and W. Papsch, who made copies and distributed them to some cactus friends. In this "edition" (Hold & Papsch 1992: 134) the combination *G. tilcarense* (Backeberg) Schütz was printed. Although in the original manuscript this name was listed, it was deleted by Schütz in the final publication of the book (Schütz 1986) and is missing also in the supplement (1988). This we have to consider as the real intention of the author; the later publication of a draft or manuscript cannot be accepted as valid publication (ICBN Art. 34.1).
- G. *schickendantzii* var. *delaetii* (K. Schumann) Backeberg in Backeberg & Knuth, Kaktus-ABC: 296 (1936). Basionym: *Echinocactus delaetii* K. Schumann (1901). See entry under *G. delaetii*.
- G. *spiegazzinii* Britton & Rose, The Cactaceae 3: 155 (1922). New name for *Echinocactus loricatus* Spegazzini (1905) non Poselger (1853). Lectotype (designated by Kiesling & Metzing in Darwiniana 34: 403, 1996): Britton & Rose, l.c. fig. 162 (1922).
- ¶G. *spiegazzinii* ssp. *cardenasianum* (F. Ritter) Kiesling & Metzing, Darwiniana 34: 404 (1996). Basionym: *G. cardenasianum* F. Ritter (1964).
- G. *stellatum* Spegazzini, Anales Soc. Ci. Argent. 99: 142–143 (1925). Previously illegitimately published as *Echinocactus stellatus* Spegazzini non Scheidweiler (1840), nom. illeg. (Art. 53; see Strong, 1975); Anales Mus. Nac. Buenos Aires 11 (ser. 2, 4): 505 (1905). Lectotype (designated by Till in: *Gymnocalycium* 8: 166 (1995): Illustration in Spegazzini, Anales Soc. Ci. Argent. 99: 143 (1925)).
- ¶G. *stellatum* ssp. *occultum* H. Till & W. Till, *Gymnocalycium* 9(2): 176 (1996). Type: Argentina, Prov. Catamarca, between San Fernando de Valle de Catamarca and Miraflores, 600 m, 18 Dec 1991, *G. Neuhuber* 91-461/1478 (WU). Based on *G. occultum* Fric ex Schütz (1962), nom. inval.
- ¶G. *stellatum* var. *flavispinum* H. Till & W. Till, *Gymnocalycium* 9(1): 172 (1996). Type: Argentina, Prov. Cordoba, between Carlos Paz and Villa La Serranita, 800–900 m, 22 Oct 1988, *H. Till* 88-225/2350 (WU, holo.). Based on *G. quehlianum* var. *flavispinum* Bozsing, nom. inval.
- ¶G. *stellatum* var. *kleinianum* H. Till & W. Till, *Gymnocalycium* 9(1): 171 (1996). Type: Argentina, Prov. Cordoba, between La Cumbre and Cosquin, 800 m, 28 Sep 1988, *H. Till* 88-116/1710, (WU). Based on *G. quehlianum* var. *kleinianum* Rausch, nom. nud.
- G. *stellatum* var. *minimum* Pazout in Pazout, Valnicek & Subík, Kaktusy :131 (1960). nom. inval. (Art. 37.1).
- G. *stellatum* var. *minimum* (Pazout) Strong, Natl. Cact. Succ. J. 30(2): 49–50 (1975), nom. inval. (Art. 33.2). Based on *G. asterium* var. *minimum* Pazout nom. inval.
- ¶G. *stellatum* var. *obductum* (Piltz) H. Till & W. Till, *Gymnocalycium* 9(1): 174 (1996). Basionym: *G. obductum* Piltz (1990).
- ¶G. *stellatum* var. *zantnerianum* (Schick) H. Till & W. Till, *Gymnocalycium* 9(1): 169
